- 3. To elect the six nominees of the Company standing for election as directors of the Company to hold office until the next annual meeting of shareholders or until his or her successor is duly elected or appointed;
- 4. To appoint PricewaterhouseCoopers SA, as the auditor of the Company, to hold office until the next annual general meeting of shareholders and to authorize the directors to fix the auditor's remuneration;
- 5. To approve the proposed amendments to, and renewal of, the Company's Incentive Stock Option Plan;
- 6. To approve the proposed amendments to the Company's Deferred Share Unit Plan; and
- 7. To transact such other business as may properly come before the Meeting or any adjournment(s) or postponement(s) of the Meeting.

The record date for determining shareholders entitled to vote at the Meeting will be fixed at the close of business (Mountain time) on May 5, 2023.
